SAMPLE QUESTION FORMATS FOR DATA COLLECTION

PROPOSED Question Format for the New Mexico BRFSS 2017 (NMDOH Proposal)

The next two questions are about gender identity. We ask these questions in order to better understand the health and health care needs of transgender and gender non-conforming people.

- a.) What sex were you assigned at birth, on your original birth certificate?
 - 1 Male
 - 2 Female

- 7 Don't Know/Not Sure
- 9 Refused

- b.) How do you describe yourself?
 - 1 a. Male
 - b. Female
 - 3 c. Transgender
 - 4 d. Gender non-conforming
 - 8 Other, specify
 - 7 Don't Know/Not Sure
 - 9 Refused

Transgender is a term used to describe a person whose gender identity differs from the sex that they were assigned at birth. For example, a person who considers themselves to be male but was assigned female gender at birth.

Gender Non-conforming: Gender Non-conforming is a term used to describe a person who does not subscribe to conventional genders but identifies with a combination of male and female gender or neither male or female gender.

Interagency Working Group to Improve Federal Survey Measurement of the LGBT Population (LGBT IWG), Office of Management & Budget (OMB)

The following question formats for sex, gender identity and sexual identity were presented at a panel of the American Sociological Association 2015 Annual Meeting. The theme for the 2015 Annual Meeting was "Sexualities in Our Social World." At the panel, Dr. Jennifer Park, Director, Office of Management and Budget (OMB), described the work of the Interagency Working Group to Improve Federal Survey Measurement of the LGBT Population (LGBT IWG). The LGBT IWG was established in 2015 to examine sexual orientation and gender identification question in Federal Surveys with the goal of improving measurement with a focus on understanding and interrupting disparities. This data can be used for multiple purposes, including tracking demographic changes, residential patterns, discipline, homelessness, curriculum tracking, employment, health outcomes and law enforcement. We need better measures of sex, gender and sexual orientation so that we can monitor and interrupt experiences of discrimination.
