STATEMENT OF THE INSTITUTE FOR THE STUDY OF "RACE" & SOCIAL JUSTICE, THE UNIVERSITY OF NEW MEXICO (race.unm.edu)

The undersigned advisory board members of the Institute for the Study of "Race" & Social Justice at the University of New Mexico (race.unm.edu) are writing with regard to New Mexico House Bill HB 91 prohibiting the teaching of "critical race theory" in public schools. As scholars of race and social justice who have lifelong peer-reviewed records of research, teaching and community engagement, we believe that HB 91 should be rejected for several reasons:

- 1.) it presents false information about critical race theory with no factual basis;
- 2.) critical race theory is not taught in public schools;
- 3.) it nullifies discussion of the history and contemporary dynamics of race, racism and social justice in the U.S. and beyond;
- 4.) it places a target on the backs of teachers who have dedicated their lives to cultivating lifelong learning through critical thinking to educate our youth.

Thank you for your attention to this important matter. As interdisciplinary scholars of race and social justice at UNM we would be happy to discuss the policy implications of these proposed restrictions to the discussion of race and social justice in our public schools and the research evidence that shows the benefits of these discussions for cultivating student success and creating healthy and loving communities.
