#### Pre-Conference Workshops – Thursday, February 22

Workshop 1 A Framework for Serving Latino Students: Deconstructing What that Means for You at Your Institution Deborah Santiago, CEO, Excelencia in Education

Developing the ability to serve Latino students enhances the capacities of institutions to serve all students. This workshop will engage participants through a series of exercises to consider their institution's data, evidence-based practice, and leadership strategies that can increase student success and degree completion.

Workshop 2 Retaining Learning, Retaining Students: Helping Students Plan for, Monitor, and Evaluate Their Learning
New Mexico State University Faculty

Patti Wojahn, Department Head Interdisciplinary Studies and Professor, Rhetoric and Professional Communication; Muhammed Dawood, Associate Professor, Electrical Engineering; Karen Trujillo, Research Faculty, College of Education and Director of The Alliance of the Advancement of Teaching and Learning; and Melissa Guynn, Associate Professor, Department of Psychology

This workshop offers strategies for helping students "learn to learn" by increasing their metacognitive awareness and improving their approaches to studying. Participants will be introduced to (1) instruments for measuring metacognitive awareness and study skill practices and (2) strategies for helping students take responsibility for their own learning through specific practices shown to be effective for learning. After considering results from a 3-year study of instituting such practices in first-year engineering courses will be shared along with insights gained from querying students through reflective journals

on their studying and preparation for exams, participants will work on plans to incorporate "learning to learn" strategies without compromising attention to content or other critical aspects of a selected course.

### Workshop 3 Pathways for HLC Accreditation: Are we on the right path for success, and if not, how do we "recalculate our route" to get us to our desired destination?

The Higher Learning Commission's (relatively) new "Pathways" for reaffirmation of accreditation are not always clearly marked; and the existing markings are not always clearly understood by everyone at our own institutions. It is in the state's best interest for all higher education institutions in New Mexico to navigate the HLC Pathways successfully; NM institutions can, and should, work collaboratively to support each other in this process. This workshop will focus on developing clarity about HLC expectations for accreditation, and specifically on preparing the Assurance Argument (including the Federal Compliance Report) and the campus community for a site visit. If you have an upcoming report or site visit, you may want to have a team of members from your institution attend.
