As of July 21, 2020 the national self-response rate was 62.3 percent and in New Mexico the self-response rate was 52.1 percent. In 2010 New Mexico's self-response rate was 60 percent. We need every UNM Student Faculty Staff person to reach out to their local community to increase 2020 Census self-response rate.
